# FEATURES

- Waterproof
- Air valveLockable zipper pulls
- Removable hi-vis orange insert, with removable storage pouch
- Tie-down points: soft, light weight, noise-free
- Detachable exterior cargo net
- Bottle pockets

#### **MOUNTING SUGGESTIONS**

Use at least four (4) mounting points to secure the bag to the bike.

Refer to PIC 2 through 4. Use the lash mounts on the bag and the provided straps to secure the bag to desired mounting locations. Attach strap to lash mount by inserting the metal loops located on the end of the strap through the lash and folding it up and over the top of the lash. Pull down on the strap to test for security of it.

Do not secure mounting straps to moving components such as the swingarm, secure it to stationary objects only.

"Pre-load" the straps by applying downward force (without deforming the bag) as the straps are tightened.

Refer to PIC 5 and 6. Fold excess length of strap and secure it into the strap keep.

**NOTICE** VERIFY THE BAG IS SECURELY ATTACHED BEFORE OPERATING THE MOTORCYCLE. SECURE ALL STRAPS AWAY FROM PAINTED SURFACES, MOVING PARTS, PINCH POINTS OR HEAT. CHECK THE STRAPS BEFORE EACH RIDE AND AT EACH STOP. BAG CONTENTS MAY SHIFT DURING OPERATION WHICH CAN RESULT IN LOOSE STRAPS. ROLL UP ANY EXCESS LENGTH IN ANY OF THE STRAPS, AND SECURE IT TO THE TAUGHT STRAP USING THE ATTACHED HOOK AND LOOP STRAP.
